- 2. **The Community Grants Breakfast** Our annual distribution of grant funds to nonprofit agencies. Over 200 attendees gather to receive grant awards. The Foundation distributes approximately one quarter of its annual grants at this event. Event occurs in April.
- 3. **Scholarship Awards Ceremony** The Longmont Community Foundation manages scholarship funds and makes these awards at a spring gathering attended by future college students, their parents and high school administrators and counselors. Event occurs in May.
- 4. **Donor/Business Partners Open House** An exclusive event to mix and network with our donors, volunteers and those involved with the Foundation. Event occurs in December.
- 5. **Invitations to Learning Seminars** each year the Foundation hosts seminars in family philanthropy and other topics of interests to businesses.
